# Reconnecting Communities: Highways to Boulevards Program

\$149 million was established in the FY 22/23 State Budget to reconnect communities divided by transportation infrastructure. RC:H2B will issue a "Call for Communities" and award to those in need to address the historical harm to their communities.



The proposed Green TI, parkland served by a small road, would replace a mile of the Terminal


7 PROGRAMMATIC GOALS (PARAPHRASED)



Previous Workshop #3 was held on March 7th.



# **Overview of Changes**

High level List of Sections that have been Amended since the previous available draft.

- Urban, Rural, and Corridor Definitions
- Proposed Improvement Area (previously called "Project Area")
- Added staff salaries and indirect cost rate information
- Added Grant Agreement and Sub-Contracts Section
- Added Delivery Methods Section
- Revised Evaluation Criteria
- Expanded and clarified different definitions as applicable.




### **Grant Categories**

BASED ON 2010 US CENSUS BUREAU DESIGNATION

Three communities will be awarded under three grant categories:

- 1. Urban –Communities with populations of 50,000 or more. Urban clusters with at least 2,500 but fewer than 50,000.
- 2. Rural Areas with less than 50,000 people.
- Corridor Linear geographic facility that support the needs of multiple underserved rural or urban communities. The corridor does not necessarily need to be the eligible transportation barrier facility but must at a minimum be impacted by the eligible facility.





### **Reconnecting Communities**

OVERVIEW OF THE TWO SEPARATE PROGRAMS - STATE AND FEDERAL

#### State Funded: RC:H2B

- Administered by Caltrans DLA
- 1 time competitive award to a "community" based on need.
- 100% State Funded funding source
- Legislative goal to "provide matching funding for potential federal grant funds"
- Awardees may also work with Caltrans to submit a proposal for RCP Cycle 3.

#### Federal Funded: RCP

- Administered by US DOT
- Multi-Cycle Pilot Program
- Competitive awards for Planning and Implementation Projects.
- Cycle 1, Caltrans issued a call for nominations, submitted 3 applications as a lead, partnered on 21, and provided 22 letters of support.
- Cycle 2 Caltrans will issue call for support/partnerships shortly.

#### Eligible Applicants Lead Applicant

# Eligible applicants may include, but not limited to:

- Units of local government
- Metropolitan Planning Organizations (MPOs)
- Local and regional agencies
- Joint powers authorities
- Federally recognized Tribal governments
- Transit agencies

- Must have an existing Master Agreement with DLA.
- Act as grant administrator, but may identify a separate implementing agency for any phase.
- Caltrans <u>can not</u> be a lead applicant

#### Co - Applicant

- Must be an eligible applicant.
- If on the SHS, Caltrans must be a co-applicant.

#### Implementing Agency

- Must be Lead or Co-Applicant (eligible applicant)
- Must have an existing Master Agreement with DLA.

#### <u>Partner</u>

- May or may not be an eligible applicant
- Provide value to the project in a meaningful way



### **Agreement Process**

WE WILL UTILIZE THE DIVISION OF LOCAL ASSISTANCE (DLA) MASTER AGREEMENT

Lead Applicant must have an existing Master Agreement, or in process of obtaining one, with DLA at time of proposal submission.


 Caltrans can support Agencies by building communication bridges with potential co-applicants and partners to round out administration needs.

Implementing agency must have an existing DLA Master Agreement prior to execution of a PSA for their associated phase or phase component. Not needed at time of application submission.

PSA to be executed prior to each phase to disperse funds on an established scope, schedule, and budget.

TYPICAL PHASE FOLLOWING COMMUNITY READINESS

Deliverable will be a Planning Document. Will include the full scope of the needs the community identified. Including non-transportation related scope.

Planning Phase Establish a Scope, Schedule and Budget for the next phase, most likely PA&ED.

May identify some components that may be delivered independently of the larger Construction Scope.

Initial Screening Self Assessment.

Online application form and attachments will be posted to website.

Applicants will have the option to attend Open Office Hours.

Application Workshops will be held to guide applicants in the application process.





OPTIONAL TOOL FOR APPLICANTS TO ASSESS IF THEIR PROJECT MAY BE A GOOD CANDIDATE FOR THIS GRANT

- Checklist provided in the Program Guidelines
- Pre-Screening Questions provided in the Program Guidelines
  - These are optional but it is encouraged to answer these questions prior to meeting during Open Office Hours.
- Optional Open Office Hours will be held during the Application Preparation Phase.
  - Attendance at these Open Office Hours does not affect the competitive nature of the application.
  - Note that these are virtual.

### **Underserved Community**

COMBINATION OF BOTH STATE AND FEDERAL TOOLS/DEFINITIONS

#### **STATE METRICS**

Must pick at least 1 metric to qualify

- By income disparity (80% AMI or less)
- By health disparity (Healthy Places Index 3.0)
- By environmental justice disparity (CalEnviroScreen)
- Native American Tribal Lands

#### FEDERAL METRICS

Must pick at least 1 metric to qualify

- By environmental justice disparity (Historically Disadvantaged Census Tracts/Justice40)
- By income disparity (Areas of Persistent Poverty)
- Many other federal metrics endorsed by the federal RCP



### Supplemental Resources to Manage Change

- Pre-screening set of questions and open office hours to help assess if this program is right for you
- Resource Document: best practices and tools for each evaluation factor to help potential applicants for building the narrative to support how a proposal aligns best to program goals.



# Assessing Alignment & Community Readiness

Top three biggest factors of the six total:

- 1. Removing Barriers and Reconnection (25 pts) understanding historical harm
- 2. Partnership (25 pts) intent and capacity to work with those most impacted by disconnection
- Community Involvement, Justice and Prosperity (30 pts) scoping equitable and meaningful planning and implementation processes



# Assessing Alignment & Community Readiness

Remaining Alignment factors:

- 4. Affirmatively Furthering Fair Housing and Addressing Housing Need (10 pts) – understanding opportunity and needs, involvement
- 5. Climate Action and Resilience (5 pts) understanding vulnerabilities and climate targets, building resilience and not undermining targets
- 6. Displacement Avoidance (5 pts) understanding vulnerabilities and supporting existing or new efforts to mitigate direct and indirect, immediate and long-term displacement






