WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to construct and operate a new District 5 maintenance station and equipment shop and associated site improvements on state-owned property (APN 076-071016) at 4485 Vachell Lane in San Luis Obispo County, California. After construction is complete, the project proposes to relocate the existing facilities, equipment, and employees of the District 5 Maintenance Station and Equipment Shop currently located at 66 Madonna Road and 50 Higuera Street. Two build alternatives are being evaluated: Alternative 1 would provide the project site with onsite water and sewer through the construction of a new groundwater well and

septic system. Alternative 2 would provide the project site with water and sewer from the City of San Luis Obispo through the construction of new water and sewer pipelines along Vachell Lane, Buckley Road, and South Higuera Street.

WHY THIS PUBLIC NOTICE?

Our studies show the project will significantly affect the quality of the environment, as documented in a report called a Draft Environmental Impact Report, which is now available for you to read and comment on. With implementation of the proposed mitigation measures, project impacts related to biological resources, cultural resources, geology and soils, hazards and hazardous materials, hydrology and water quality, noise, transportation, utilities and service systems and wildfire would be less than significant. However, project impacts related to aesthetic resources and agricultural resources would be significant and unavoidable, since mitigation measures identified in the Draft Environmental Impact Report were determined infeasible or would not reduce these impacts to a less-thansignificant level. The project site is not listed on any of the lists of hazardous materials sites enumerated under Section 65962.5 of the Government Code. A hybrid public meeting (both in person and online) will be held to give you an opportunity to talk about features and impacts of the project with Caltrans staff before the final design is selected.
