

We are writing in response to your August 15, 2008 letter inviting the U.S. Environmental Protection Agency (EPA) to become a Participating and Cooperating Agency for the I-710 Corridor Project (I-710), Los Angeles County, California. The California Department of Transportation (Caltrans), in cooperation with Los Angeles County Metropolitan Transportation Authority (Metro), will prepare an Environmental Impact Statement (EIS) for the project under National Environmental Policy Act (NEPA).

The State of California has assumed responsibilities under NEPA for this project pursuant to the *Memorandum of Understanding Between the Federal Highway Administration (FHWA) and Caltrans Concerning the State of California's Participation in the Surface Transportation Project Delivery Pilot Program*.

EPA accepts Caltrans' invitation to become a "Participating Agency" (as defined in 23 USC 139 Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)) and a "Cooperating Agency" (as defined in NEPA). We look forward to working with Caltrans to ensure that the SAFETEA-LU implementation procedures assist both our agencies in meeting our statutory missions.

As a Participating and Cooperating Agency, we define EPA's role in the development of the project to include the following as they relate to our jurisdiction by law or areas of expertise:

- 1) Provide meaningful and early input on defining purpose and need, determining the range of alternatives to be considered, and the methodologies and level of detail required in alternatives analysis.
- 2) Participate in coordination meetings and joint field reviews as appropriate and as resources allow.
- 3) Timely review and comment on the pre-draft or pre-final environmental documents as appropriate and as resources allow (*including technical reports, plans and/or scoping documents related to human health risk assessment, mobile source air toxics, traffic analysis, air quality, green-building, wetlands/waters, biological resources, cumulative impacts assessment, and conceptual mitigation*) to reflect the views and concerns of EPA

on the adequacy of the documents, alternatives considered, anticipated impacts, and avoidance, minimization, and mitigation strategies.

- 4) Timely review and comment on a draft coordination plan, outreach strategy and plan to evaluate environmental justice impacts.

This project may meet the criteria for coordination under the April 2006 *National Environmental Policy Act and Clean Water Action Section 404 Integration Process for Federal Aid Surface Transportation Projects in California Memorandum of Understanding* (NEPA/404 MOU). The NEPA/404 MOU includes specific agreement points to assist in developing the EIS and involves active participation in meetings and document reviews. It applies to transportation projects that have five or more acres of permanent impacts to waters of the United States and require EIS preparation. We encourage FHWA and Caltrans to contact the NEPA/404 signatory agencies once more information about the potential impact to waters of the United States is available in order to initiate coordination under the NEPA/404 MOU, if applicable. EPA further recommends that Caltrans consider following the NEPA/404 MOU process to structure the project's early coordination even if the waters of the United States threshold is not triggered. The NEPA/404 MOU allows for the process to apply to other projects if all of the NEPA/404 MOU signatory agencies agree.

We appreciate Caltrans' interest in working with EPA and look forward to participating in the project's EIS development. EPA's participation as a Participating or a Cooperating Agency does not constitute formal or informal approval of any part of this project under any statute administered by EPA, nor does it limit in any way EPA's independent review of the Draft and Final EISs pursuant to Section 309 of the Clean Air Act. This letter is in response to your letter of August 15 2008 requesting our agency, the Department of Homeland Security (DHS), Federal Emergency Management Agency (FEMA), to become a participating agency per Section 6002 of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) in the environmental process for the Interstate 710 Corridor Project in Los Angeles County.

FEMA is declining your invitation to be a participating agency, as we do not have jurisdiction or authority with respect to the proposed improvements. The project, however, must undergo Federal consultation with agencies responsible for implementation of Federal environmental statutes and authorities, as it is considered equivalent to a Federal action, being proposed by the Federal Highway Administration (FHWA) in cooperation with the Los Angeles County Metropolitan Transportation Authority (METRO).


The proposed improvements are in Los Angeles County, which participates in the National Flood Insurance Program (NFIP). Any development within this County must comply with requirements of the County's Flood Damage Prevention Ordinance (Ordinance). This Ordinance regulates development within the high risk Special Flood Hazard Area (SFHA), and meets the minimum Federal requirements established in Title 44 of the Code of Federal Regulations (44 CFR). Development is defined as: "any man-made change to improved or unimproved real estate, including but not limited to dredging, filling, grading, paving, excavation, or drilling operations or storage of equipment or materials." (44 CFR Part 59).

To complete the Federal review process for the proposed project, METRO is required to submit the draft of the environmental compliance document to seek comments from our agency.

The Southern California Regional Rail Authority (SCRRA) accepts your invitation to participate in the I-710 Corridor Project pursuant to Section 6002 of SAFETEA-LU. The project area intersects Metrolink service along the Burlington Northern Santa Fe Railway (BNSF) and Union Pacific (UP)-owned tracks on which Metrolink operates, and SCRRA welcomes the opportunity to participate in the project planning phases.

As background information, SCRRA is a five-county Joint Powers Authority (JPA) that operates the regional commuter rail system known as Metrolink. Additionally, SCRRA provides rail engineering, construction, operations and maintenance services to its five JPA member agencies. The JPA consists of the Los Angeles County Metropolitan Transportation Authority (MTA), San Bernardino Associated Governments (SANBAG), the Orange County Transportation Authority (OCTA), the Riverside County Transportation Commission (RCTC) and the Ventura County Transportation Commission (VCTC). Three Metrolink routes operate through the I-710 project area: the Orange County Line and the 91 Line along the BNSF's San Bernardino subdivision, and the Riverside Line along the UP's Los Angeles subdivision.


