Dear Mr. McMillan,

Stimpel-Wiebelhaus Associates Inc. hereby protests the award of the above mentioned project to Mercer Fraser Company for failing to list a subcontractor for Bid Item # 45- Drill Hole (Horizontal Drain), failing to fill out the Work Category Codes on the DBE Commitment form, and for falsely stating their subcontractor AC Dike Company if performing 100% of Bid Items 34, 35, & 36.

Bid Item #45- Drill Hole (Horizontal Drain)- Most General License A contractors in the State of California do not self-perform the requirements of Bid Item #45- Drill Hole (Horizontal Drain) and therefore must sub contract it out. Mercer Fraser Company does not self-perform Horizontal Drilling and has no intention of self-performing it. The most competitive sub quote for Bid Item #45- Drill Hole (Horizontal Drain) was \$17,120, which is in excess of ½ of 1 % of the total bid amount. Per Standard Specification 2-1.10 Subcontractor List- "On the subcontractor list form, list each subcontractor to perform work in an amount in excess of ½ of 1 percent of the total bid or \$10,000, whichever is greater."

Mercer Fraser Company failed to provide Work Category Codes for their subcontractors on their DBE Commitment form, rendering the form incomplete. Per Note #3 on the Des-OE0102 10D Form "USE WORK CATEGORY CODES FROM THE CALIFORNIA UNIFIED CERTIFICATION PROGRAM DATABASE." Failing to fill out part or all of the required DBE Commitment forms is basis for being deemed non-responsive.

Mercer Fraser Company states their subcontractor AC Dike Company is performing 100% of Bid Items 34, 35, & 36. Attached is AC Dike Company's quote which states "PLACE ONLY 770 LF ASPHALT DIKE TYPE (C, D, F). Furthermore, AC Dike Company's conditions state "ASPHALT AND TRUCKING BY PRIME CONTRACTOR." AC Dike Company is ONLY placing the Asphalt Dike Type (C, D, F), which is only part of the bid items. Mercer Fraser

Company must supply and provide the material and trucking, therefore the subcontractor form submitted by Mercer Fraser Company is incomplete.

Mercer Fraser Company failed to list a subcontractor that was in excess of ½ of 1% and \$10,000, failed to properly fill out DBE Commitment DES-OE-0102 10D, and falsely stated a subcontractor was performing 100% of Bid Items 34, 35, 36. Because of these reasons Stimpel-Wiebelhaus Associates Inc. request Mercer Fraser Company be deemed non-responsive and the contract be awarded to the next responsive low bidder.
