

Caltrans conducted a review of the bid documents submitted by Marina. The Subcontractor List form was submitted on bid day and there was no subsequent 24 hour Subcontractor List form submitted. As such, there were no changes made to the submission and the absence of the description of work description for bid item 69, "Maintaining existing traffic management system elements during construction," is immaterial as the bid item number was identified on bid day.

Based on the above, Caltrans finds that B&W's protest does not have merit and will proceed to award the contract to the lowest responsible bidder, provided that all requirements have been met.


