Dear Mr. Amer:

The Department of Transportation (Caltrans) received a bid submitted by Yakar for Contract No. 07-2768U4 on August 08, 2013. By this letter, Caltrans notifies Yakar that its bid is nonresponsive because of inconsistencies listed in its Subcontractors List form and DBE Commitment form.

*The Caltrans Bidder-DBE-Commitment form states in part... "DBE Subcontractors and their respective item(s) of work listed above must be consistent, where applicable, with the names and items of work in the "Subcontractors List" submitted with your bid."*

Yakar submitted its DBE Commitment form listing LSS to perform Bid Item 8, described as Temporary Mulch and Bid Item 16, described as Roadside Clearing. However, on the Subcontractors List form submitted on 08/08/2013, LSS was not listed.

As you are aware, the instructions for submitting the Subcontractors List form states in part, "The bidder must identify each subcontractor performing work in an amount in excess of ½ of 1 percent of the total bid or \$10,000, whichever is greater." Yakar failed to list LSS to perform any portion of the work described as Temporary Mulch and Roadside Clearing.

In addition, to the DBE Submittal submitted on August 12, 2013, Caltrans received a second Subcontractors List form. Caltrans did not review this document since it was submitted after the due date of August 9, 2013, 2:00 p.m.


Based on the above, Caltrans will proceed to award this contract to the lowest responsible bidder.
