39-1.22B Materials

Asphaltic emulsion for prime coat must be Grade SS1.

39-1.22C Construction

Apply between 0.10-0.30 gal of prime coat based on the minimum percentage of residual per square yard of designated area

If you request and if authorized, you may modify prime coat application rates.

Before paving, prime coat must cure for the minimum of 4 hours or as directed by the Engineer.

Close traffic to areas receiving prime coat. Do not track prime coat onto pavement surfaces beyond the job site.

1. Contractor personnel shall carefully check under parked vehicles or equipment for desert tortoises before moving them. Desert tortoises found within the staging and/or construction areas will be allowed to move away from such areas to a location away from danger, on their own accord. Construction activities within such areas shall re-commence only once the desert tortoise is safely outside the project areas.
2. All staging, storage, batch plants, vehicle parking, and construction activities shall be enclosed by temporary fence (type desert tortoise) and shall be located in previously disturbed areas.
3. Beyond the project boundaries (existing pavement), any disturbance to native vegetation would be minimized to the greatest extent possible and must be approved by a Caltrans Biologist and/or Engineer.
4. Litter control measures will be implemented. All litter should be contained in containers with secured lids to prevent attracting common ravens or other potential predators of the desert tortoise. Workers are prevented from feeding all wildlife.
5. Construction staging, storage, and batch plant areas shall be located away from undisturbed areas, including vacant fields, with minimal risk of discharge into drainages or other sensitive habitat types. Only previously disturbed areas, such as turnouts and paved areas may be used for these purposes. The Engineer and/or Caltrans Biologist shall coordinate on such sites prior to their approval/use.
