Pursuant to the formal bid protest submitted for the above referenced project. Match Corporation submitted a timely and responsive bid on July 27, 2016 and listed Alexis Fence for items 19 "Remove Guardrail and item 45 Temporary Fence (Type Tortoise). Alexis Fence submitted a quote which included a valid California Contractors License and DIR Number, based on the included information and the fact that Match Corporation had in the past contracted with Clay Hoggard on several projects, Match Corporation was not compelled to perform a pre bid investigation.

On August 4, 2016 Match Corporation was notified by the Department of Transportation that Alexis Fence had not renewed their DIR Registration as of July 1, 2016. It is important to note that the issue was simply renewal, not registration as had been suggested in the protest. At the time, The Department of Transportation also stated that Alexis Fence would be allowed three business days to renew their existing DIR registration. The renewal was completed (see attached) on that same day and conformation of this was immediately forwarded to the Department of Transportation.


Contrary to the claim made in the protest, Alexis Fence was registered with the California Department of Industrial Relations at the time of bid. The registration was made in the name of Luis Parra, DBA Alexis Fence (see attached) as of April 27, 2016. As per The Department of Industrial Relations News line No. 2016-63. "The early renewal option is only available for public works contractors who are currently registered with DIR". Furthermore as per the CA.Gov website Consequences of Noncompliance, "A penalty of \$300 may apply only to first time lapses in registration (failure to renew while bidding or working on a Public Works project) if the registration is renewed by October 1 of the same year".

Based on the quoted publications and the attached renewal, Luis Parra Construction DBA Alexis Fence was registered prior to the bid date and is in full compliance with The Department of Industrial Relations.
