

39-1.16 CENTERLINE RUMBLE STRIPS

39-1.16A General

Construct centerline rumble strips in the top layer of HMA surfacing by ground-in method.

39-1.16B Materials

Not Used

39-1.16C Construction

Select the method and equipment for constructing ground-in indentations.

Do not construct rumble strips on structures or approach slabs. Do not construct centerline rumble strips where crossroads or driveways are present

Construct centerline rumble strips within 1 inch of the specified alignment. The grinding equipment must be equipped with a sighting device enabling the operator to maintain the rumble strip alignment.

Indentations must comply with the specified dimensions within 0.06 inch in depth and 5 percent in length and width.

The Engineer orders grinding or removal and replacement of noncompliant centerline rumble strips to bring them within specified tolerances. Ground surface areas must be neat and uniform in appearance.

The grinding equipment must be equipped with a vacuum attachment to remove residue from the roadbed.

Dispose of removed material.

On ground areas, apply fog seal coat under section 37-2.

39-1.16D Payment

Centerline rumble strips are measured by the station along the length of the rumble strips without deductions for gaps between indentations.
