RELINQUISHMENT RESOLUTIONS

The Department of Transportation recommends the California Transportation Commission approve Relinquishment Resolution R-3473 - R-3477.

All superseded highways included in the relinquishment resolutions summarized below are in a state of good repair. The local authorities have been advised of the pending relinquishments a minimum of 90 days prior to the Commission meeting for both superseded highways and collateral facilities pursuant to Section 73 of the Streets and Highways Code. Any exceptions or unusual circumstances are described by the individual summaries.

R-3473 – 3-Sac-16-PM 9.4/11.4 (Request No. 31490-X) – 3 Segments

Relinquishes right of way in the County of Sacramento, at Eagles Nest Road and Tree View Road, consisting of county road connections. The County by cooperative agreement dated January 16, 1996, agreed to accept title upon relinquishment by the State. Project accepted on November 20, 1996. The 90-day notice period expired October 25, 2000, without exception.

R-3474 – 4-Ala-80-PM 7.2 (Request No. 56042) – 1 Segment

Relinquishes right of way in the City of Albany, at Buchanan Street, consisting of reconstructed city street. Project accepted on April 13, 2000. The City by cooperative agreement dated May 15, 2000, waived the 90-day notice requirement and agreed to accept title upon relinquishment by the State.

R-3475 – 4-Ala-880-PM 20.2/20.4 (Request No. 56038) – 1 Segment

Relinquishes right of way in the City of San Leandro, between Lewelling Boulevard and Hesperian Boulevard, consisting of reconstructed city street. Project accepted on February 24, 1992. The City by resolution dated November 6, 2000, waived the 90-day notice requirement and agreed to accept title upon relinquishment by the State.

R-3476 – 4-Sol-780-PM 7.4 (Request No. 260) – 2 Segments

Relinquishes right of way in the County of Solano, on Reis Avenue, consisting of relocated and reconstructed city street, frontage road and cul-de-sac. The County by freeway agreement dated March 30, 1966, agreed to accept title upon relinquishment by the State. Project accepted on July 11, 1985. The 90-day notice period expired December 16, 2000, without exception.

R-3477 – 4-Son-101-PM 22.8 (Request No. 56028) – 1 Segment

Relinquishes right of way in the City of Santa Rosa, 0.4 mile northwesterly of Fountaingrove Parkway, consisting of frontage road. Project completed on December 5, 1962. The City by letter dated April 4, 2000, agreed to accept title upon relinquishment by the State. The 90-day notice period expired October 26, 2000, without exception.
