**ACTION UPDATE FROM NOTICE**

This item was noticed at the February 2001 Commission meeting; the Commission requested the Action Item be placed on the consent calendar.

**SUMMARY**

This amendment combines a Grandfathered Regional Improvement Program (GFRIP) funded oak tree landscape mitigation project on Route 30 in Los Angeles County with a related GFRIP funded landscape mitigation project on the same route. The total cost remains the same.

**BACKGROUND**

This amendment combines a \$235,000 Grandfathered Regional Improvement Program (GFRIP) funded Oak Tree Landscape mitigation project (PPNO 0422K) on Route 30 in Los Angeles County with a related GFRIP funded landscape mitigation project (PPNO 0422Y) on the same route. The total cost remains the same.

Two landscape mitigation projects are currently programmed on Route 30 in Los Angeles County, one for oak tree mitigation in FY 2001-02 (PPNO 0422K) and one for general landscape mitigation (PPNO 0422Y) in FY 2002-03. At the time these two mitigation projects were split from the parent project, the Department planned to work with the City of Claremont to meet the oak tree mitigation requirement by arranging for planting of seedlings outside of the State right of way. Subsequently, the Department and the Department of Fish and Game have agreed that it would be more cost effective to combine the oak tree mitigation with the general landscape mitigation and plant the seedlings inside the right of way. While this amendment moves the programmed year of construction for the oak tree mitigation project out one year and combines it with the landscape mitigation project, the final mitigation for the oak trees should not be delayed. Combining the projects will allow the same contractor to handle the mitigation work, tree planting and plant establishment. The schedule for seedling propagation will be maintained as explained below.



The oak tree mitigation portion of the above contract will require the state's contractor to plant a large number of seedlings within the State's right of way. Oak tree seedlings must be propagated from acorns a year prior to planting. To ensure a sufficient number of oak seedlings are available when the mitigation project is ready, the Department will request an early partial allocation for a service contract to grow the necessary seedlings. The seedlings will be provided as state furnished material on the landscape mitigation contract.
