STIP AMENDMENT 00S-016 NOTICE

SUMMARY

This amendment programs \$2,342,000 from Shasta County's Unprogrammed Share Balance for two projects near Redding in Shasta County. One is a roadway improvement project on Deschutes Road and the other is a roadway rehabilitation project on Oak Run and Buzzard Roost Roads.

RECOMMENDATION

The Shasta County Regional Transportation Planning Agency is requesting this amendment. The Department has reviewed the amendment and found it to be consistent with the Commission adopted STIP guidelines.

BACKGROUND

This amendment programs \$2,342,000 from Shasta County's Unprogrammed Share Balance for two projects near Redding in Shasta County: \$1,300,000 for the construction component for a roadway improvement project on Deschutes Road and \$1,042,000 for a roadway rehabilitation project on Oak Run and Buzzard Roost Roads.


The environmental and design components of the Deschutes Road project were previously programmed and the construction component is now ready for programming. After completion of the environmental process the project limits have become more defined and have been revised to reflect the current limits of work.

The environmental and PS&E phases for the Oak Run and Buzzard Roost Road rehabilitation project are being funded with local road funds. This project is on schedule for being constructed this summer.
