BACKGROUND

This amendment revises the programming of Calaveras County's Regional Improvement Program funds for Project Planning, Programming and Monitoring (PPM), with no change in Alpine, Amador, and Calaveras Counties' unprogrammed share balances.

By agreement among the three counties, the County Share Balances are combined. The three counties support the Calaveras Council of Governments' request that the programming of PPM for Calaveras be amended to make \$79,000 available in fiscal year (FY) 01/02, \$41,000 in FY 02/03, and \$0 in FY 03/04.
