**STIP AMENDMENT 00S-038 ACTION**

**ACTION UPDATE FROM NOTICE**

This item was noticed at the May 2001 Commission meeting; the Commission requested the Action Item be placed on the consent calendar.

**SUMMARY**

This amendment reprograms \$600,000 in Grandfathered Regional Improvement Program (GF-RIP) funds between the construction components of two mitigation projects on Route 15 in San Diego County by reducing \$600,000 from a soundwall project programmed in FY 2001-02 and adding \$600,000 to a planting project programmed in FY 2000-01.

**RECOMMENDATION**

The San Diego Association of Governments (SANDAG) is requesting this amendment. The Department has reviewed the amendment and found it to be consistent with the Commission adopted STIP guidelines.

**BACKGROUND**

This amendment reprograms \$600,000 in Grandfathered Regional Improvement Program (GF-RIP) funds between the construction components of two mitigation projects on Route 15 in San Diego County by reducing \$600,000 from a soundwall project programmed in FY 2001-02 and adding \$600,000 to a planting project programmed in FY 2000-01.

These are both mitigation projects associated with the Route 15, 40th Street highway construction project in San Diego. They involve the last of the three parks designed and built as part of Caltrans' environmental commitment for the 40th Street project (EA 048681). The scope and cost estimate of the planting project (PPNO 0205Y) was revised during the preparation of the project report to be consistent with the State's commitments and the City of San Diego's General Development Plan (GDP) approved in October 2000. The \$600,000 cost increase for this project will come from a cost savings in the other 40th Street mitigation project for soundwalls (PPNO 0202H). The savings on the soundwall project is due to the change in the strategy of noise mitigation from exterior conventional noise barrier to interior noise abatement.


