STIP AMENDMENT 98S-146 ACTION

ACTION UPDATE FROM NOTICE

This item was noticed at the July 2000 Commission meeting; the Commission requested the Action Item be placed on the consent calendar as originally proposed.

SUMMARY

This amendment transfers \$600,000 in Grandfathered Regional Improvement Program (GF-RIP) funds from the Route 37 New 4-Lane Freeway project to the Route 37 Environmental Mitigation project in Solano County. Both projects are programmed in the 1998 STIP for construction in FY 2000-01. The construction cost for the New 4-Lane Freeway project decreases from \$22,593,000 to \$21,993,000 while the construction cost for the Environmental Mitigation project increases from \$3,000,000 to \$3,600,000. Solano County's Unprogrammed Share Balance remains unchanged.

RECOMMENDATION

The Department is requesting this amendment. The Metropolitan Transportation Commission recommends approval of this document.

BACKGROUND

This amendment transfers \$600,000 in Grandfathered Regional Improvement Program (GF-RIP) funds from the Route 37 New 4-Lane Freeway project to the Route 37 Environmental Mitigation project in Solano County. Both projects are programmed in the 1998 STIP for construction in FY 2000-01. The construction cost for the New 4-Lane Freeway project decreases from \$22,593,000 to \$21,993,000 while the construction cost for the Environmental Mitigation project increases from \$3,000,000 to \$3,600,000. Solano County's Unprogrammed Share Balance remains unchanged.

At the March 30, 2000 Commission meeting, under STIP Amendment 98S-106, the New 4-Lane Freeway project was split into three separate contracts. The first contract at a cost of \$3,000,000 was for the required environmental mitigation work, the second contract totaling \$22,593,000 was for the construction of the new freeway and the third contract estimated at \$858,000 was for freeway planting.

Cost estimates for both the environmental mitigation and the main construction contract for this corridor project have been refined to reflect quantity adjustments and current unit prices. The additional \$600,000 needed for environmental mitigation is covered by a less than 3 percent adjustment to the parent project so the Solano County Share Balance does not need to be adjusted.
