STIP AMENDMENT 98S-153 NOTICE

SUMMARY

This amendment programs \$4,683,000 from San Bernardino County's Unprogrammed Share Balance to six transit projects. The six include: the City of Chino's Downtown Transportation Center project, Fontana's Metrolink (Trans-center) Plaza Expansion Project, the City of Rialto's Metrolink/Bus Stop Enhancement Project, a multi-modal transit center in San Bernardino, a Phase 2 Metrolink Station Project in the City of Ontario, and the El Garces Intermodal Transfer Station restoration project in the City of Needles.

RECOMMENDATION

The San Bernardino Associated Governments (SANBAG) is requesting this amendment. The Department has reviewed the amendment and found it to be consistent with the Commission adopted STIP guidelines.

BACKGROUND

This amendment programs \$4,683,000 from San Bernardino County's Unprogrammed Share Balance to six transit projects. The six include: the City of Chino's Downtown Transportation Center project, Fontana's Metrolink (Trans-center) Plaza Expansion Project, the City of Rialto's Metrolink Bus Stop Enhancement Project, a multi-modal transit center in San Bernardino, a Phase 2 Metrolink Station Project in the City of Ontario, and the El Garces Intermodal Transfer Station restoration project in the City of Needles.

Project #1 – This amendment programs \$1,299,000 in Regional Improvement Program (RIP) funds to the City of Chino's Downtown Transportation Center for a total cost of \$1,477,000. These proposed funds will be used for completion of Phase 1 of the Downtown Transportation Center, an inter-modal project. The project involves construction of a plaza for 6 buses, property acquisition, and construction of approximately 80 parking spaces. City of Chino anticipates submitting additional requests for phases 2 and 3 in the future. Construction of bus plaza on Chino Avenue, Right of Way acquisition and initial rail platform work south of Chino Ave are planned for Phase 2. Phase 3 will construct additional improvements to the rail platform, parking and streetscape improvements.

Project #2 – This amendment programs \$392,000 in RIP funds to the Omnitrans (Fontana) for the completion of the Fontana Metrolink (Trans-center) Plaza expansion Project. RIP funds will augment the local and federal transit funds for a total project cost of \$908,000. The project will provide for a bus only access road, five additional bus bays, new bus shelters, and restroom facilities. In addition, improvements will be made to the existing bus shelter/gazebo, landscaping, sidewalks, and drainage. The project will also signalize the intersection of Juniper Avenue and Orange Way.

Project #3 – This amendment programs \$580,000 in RIP funds to the City of Rialto's Metrolink Bus Stop Enhancement Project to augment the local and federal transit funds towards the total project cost of \$1,655,000. This project will improve the overall pedestrian and intermodal connections from the Metrolink Station to the bus stops on Riverside Avenue and to the Civic Center. Improvements include

construction of a sidewalk, installation of an electronic message board, and improvements to landscape, streetscape, and handicap accessibility.

Project #4 – This amendment programs \$1,182,000 in RIP funds for the construction of a multi-modal transit center in San Bernardino. RIP funds will be augmented by \$3,373,000 in local and federal transit funds for a total project cost of \$4,555,000. The project will construct a new transcenter in downtown San Bernardino to replace the current “transit mall”. The transcenter will provide connections between 24 bus routes and will have between 32 and 36 bus bays for layover and future service expansion. It will also provide a location for a future Metrolink stop.

Project #5 – This amendment programs \$480,000 in RIP funds for the Phase 2 of their Metrolink Station Project in the City of Ontario. RIP funds will be used to augment the \$3,033,000 in Measure and TEA funds, for a total project cost of \$3,513,000. This project will complete the Francis Street entrance, parking lot expansion, and related improvements.

Project #6 – This amendment programs \$750,000 in RIP funds for a project to restore the El Garces Intermodal Transfer Station in the City of Needles. The Commission previously allocated \$428,000 in Transit Capital Improvement (TCI) funds (PPNO 08-5133) at its November 1999 meeting to secure the historic depot and perform exterior work (platform, parking, outside waiting area, bus turn around, etc). The proposed RIP funds will be used for the second phase of the project consisting of environmental, design and construction of the passenger waiting area inside the depot. The design will also provide for upgrading mechanical systems and utilities that will be built in a future phase.


When processing an allocation for these projects, several will be requested as State-only funding as being consistent with the guidelines for State-only funding.

SANBAG requested the Department process the STIP Amendment for these projects for Notice at the September CTC meeting to move these projects forward to meet delivery schedules. SANBAG's adoption of their 2000 RTIP is scheduled for October 4, 2000.


Location: In Chino, Sixth Street between Chino Avenue and D street




Location: In Rialto along the Metrolink tracks from Palm Street to Riverside Avenue


Location: In San Bernardino between E Street, Rialto Avenue, G Street, and the railroad tracks


Location: In Ontario along East Francis Street
