STIP AMENDMENT 00S-066 NOTICE

SUMMARY

This amendment programs \$1,900,000 in FY 2001-02 in Regional Improvement Program (RIP) funds from San Bernardino County's Unprogrammed Share Balance for a \$31,891,000 Metrolink project to double track portions of the San Bernardino Line. The project will be implemented by the Southern California Regional Rail Authority (SCRRA).

RECOMMENDATION

The San Bernardino Associated Governments (SANBAG) is requesting this amendment. The Department has reviewed the amendment and found it to be consistent with the Commission adopted STIP guidelines.

BACKGROUND

This amendment programs \$1,900,000 in FY 2001-02 in Regional Improvement Program (RIP) funds from San Bernardino County's Unprogrammed Share Balance for a \$31,891,000 Metrolink project to double track portions of the San Bernardino Line. The project will be implemented by the Southern California Regional Rail Authority (SCRRA).

The project will construct: a new siding track on the San Bernardino Line between the Rancho Cucamonga and Fontana stations and a 4.2-mile second main track between the Pomona and Montclair stations. The work consists of construction of a new track (with related signals and switches) at both locations and shifting an existing freight storage track to the south at the Kaiser Siding site. This project enhances the ability to operate trains in both directions on the predominately single track line through a congested area while maintaining a route for freight trains enroute between Pomona and Irwindale.

The total cost of this project is \$31,891,000, with additional funding provided by the Traffic Congestion Relief Program (TCRP), the State's General Fund, and local Federal funding. San Bernardino Associated Governments (SANBAG) is requesting RIP funding so that the construction component of this project will be fully funded. Construction is scheduled to begin in February 2002 and will be completed in April 2003. An allocation request will be submitted concurrent with the amendment action.
