The Mendocino Council of Governments (MCOG) is requesting the California Transportation Commission (Commission) to approve this State Transportation Improvement Program (STIP) amendment. This amendment was noticed at the April 2003 Commission meeting. There were no questions on the Notice and the Commission requested the Action Item be placed on the consent calendar for the May 2003 meeting.

The City of Fort Bragg proposes to delay \$167,000 of Regional Improvement Program (RIP) funds from Fiscal Year (FY) 2003-04 to FY 2004-05 for the construction phase of the Main and Laurel Signal Installation project (PPNO 4085P). This is a revenue neutral programming action. (Noticed at April 2003 CTC meeting.)

RECOMMENDATION:

The Department of Transportation (Department) recommends that the item be placed on the consent calendar for approval.

BACKGROUND:

The Mendocino Council of Governments (MCOG) proposed this project in their 2002 Regional Transportation Improvement Program document to be programmed into the 2002 STIP. In light of the recent cash flow situation, MCOG and the City of Fort Bragg are pursuing alternative avenues of funding for this project. If successful, MCOG will be replacing \$167,000 of STIP Construction funds with Pedestrian Safety Program (PSP) funds. The City will not find out if they are successful in securing the PSP funds until late June. To accommodate this schedule, the City is requesting to delay the Construction (CON) component from FY 2003-04 to FY 2004-05.


Resolved, that the California Transportation Commission (Commission) revise the 2002 State Transportation Improvement Program (STIP) at the end of the 30-day notice period as follows:
