The Colusa Local Transportation Commission (LTC) is requesting the California Transportation Commission (Commission) approve this State Transportation Improvement Program (STIP) amendment. This amendment was noticed at the October 2003 Commission meeting. There were no questions on the Notice and the Commission requested the Action Item be placed on the consent calendar for the December 2003 meeting.

Colusa County and the Colusa LTC request the Commission approve a replacement project per AB 3090. Colusa County will use local funds to replace \$436,000 in Regional Improvement Program (RIP) funds for Construction in FY 2006-07 for the Highway 99W Rehabilitation project (PPNO 3L81). Colusa County proposes to advance the Highway 99W Rehabilitation project to FY 2003-04 and program a total of \$436,000 in RIP funds in FY 2006-07 for a replacement project (PPNO 3114B) to be identified at a later date. This is a revenue neutral programming action.

RECOMMENDATION:

The Department of Transportation (Department) recommends that the AB 3090 request be approved.

BACKGROUND:

The Commission's policy on AB 3090 encourages local agencies to use local funds to advance the delivery of projects programmed in the STIP. Colusa County proposes to accelerate delivery of the construction phase of a local road rehabilitation project using local funds. In addition, the County plans to program a replacement project in the STIP, in accordance with the Commission's policy that gives preference to programming AB 3090 Replacement projects over AB 3090 direct reimbursement arrangements. The specific AB 3090 Replacement project will be amended into the STIP at a later date.

This project was programmed into the 2002 STIP at the October 2002 Commission meeting. The project was originally programmed in FY 2006-07 for \$447,000 in RIP funds. In August 2003, the Commission approved STIP Amendment 02S-094, advancing \$1,000 for Environmental (PA&ED) and \$10,000 for Design (PS&E) in RIP funds from FY 2006-07 to FY 2003-04 per AB 3090.

This amendment proposes to advance \$436,000 in RIP Construction (CON) funds from FY 2006-07 to FY 2003-04 per AB 3090. Approval of this amendment will result in the deletion of this project from the STIP. Colusa County will deliver the entire project with local Road Funds and will begin construction in May 2004.

RESOLUTION:

Resolved, that the California Transportation Commission (Commission) revise the 2002 State Transportation Improvement Program (STIP) at the end of the 30-day notice period as follows:


