Subject: **MONTHLY REPORT ON LOCAL ASSISTANCE STIP PROJECTS PREVIOUSLY VOTED BUT NOT AWARDED**

## **SUMMARY:**

The Department of Transportation (Department) is presenting this item as an Informational Item. The item provides the status of State Transportation Improvement Program (STIP) projects that received an allocation in previous fiscal years but have not yet been awarded for construction.

As of May 5, 2006, there were no locally-administered STIP projects receiving a construction allocation where the agency did not award a contract within the required time period. There are six locally-administered STIP projects, totaling \$4,148,000, that are approaching the 12-month contract award deadline within the next year. Four have been granted extensions, one agency is requesting a concurrent extension under Agenda Item 2.8b.(3), and one is expected to be awarded on time. All six projects are shown on the attachment.

## **BACKGROUND:**

Resolution G-03-19, STIP Guidelines, adopted by the California Transportation Commission (Commission) on December 11, 2003, stipulates that funds allocated for the construction phase of local grant projects are available for contract award for a period of 12 months from the date of allocation. The guidelines further stipulate that the Commission may approve waivers to the timely use of funds deadline one time only for up to 20 months, in accordance with Section 14529.8 of the Government Code.
