Subject: **STIP AMENDMENT 06S-020**

SUMMARY:

The California Department of Transportation (Department) and Sonoma County Transportation Authority (SCTA) propose to amend the State Transportation Improvement Program (STIP) to update funding plans to be consistent with the adopted Corridor Mobility Improvements Account (CMIA) funding plans for the following three projects:

- US 101 High Occupancy Vehicle (HOV) Lanes - Railroad Avenue to Rohnert Park Expressway – PPNO 0775
- US 101 HOV Lanes - Wilfred Avenue to Santa Rosa Avenue – PPNO 0781E
- US 101 HOV Lanes between Santa Rosa – Windsor – PPNO 0749A

BACKGROUND:

At the June 7, 2007 California Transportation Commission (Commission) meeting, the Commission approved the CMIA funding plans following adoption of the 2006 STIP Augmentation in April 2007. Project sponsors worked diligently to coordinate technical details between these two programs to ensure consistency. However, some details were inadvertently overlooked. This amendment revises the above projects to change programmed STIP funds, as were originally intended, in order to be consistent with the CMIA funding plans as adopted for these projects.

RESOLUTION:

Resolved, that the California Transportation Commission revise the 2006 State Transportation Improvement Program for projects PPNO 0775, PPNO 0781E, and PPNO 0749A at the end of the 30-day notice period, as follows:




