Subject: **FISCAL YEAR 2007-08 SECOND QUARTER EXCESS LAND SALES REPORT**

SUMMARY:

For the Second Quarter of Fiscal Year 2007-08 (Sixth Quarter of Disposal Report), the California Department of Transportation's (Department) disposal target was 294 parcels. The Department disposed of 159 parcels from its surplus inventory, valued at \$28,464,858. The return to the State Highway Account on the 159 parcels was \$26,383,936 for the quarter.

EXCESS LAND DISPOSAL CONTRACT STATUS:

Director Kempton and each of the District Directors have committed to disposing of 1140 parcels by December 31, 2008 (Disposal Contracts attached). The Department's goal was to dispose of 640 parcels by December 31, 2007. As of that date, 634 parcels had been disposed.

The attached report, with the detail of the contract commitments, is current as of January 17, 2008, and shows the progress that is continuing on the Disposal Contracts.
