Subject: **STIP AMENDMENT 08S-007**

RECOMMENDATION:

The California Department of Transportation (Department) recommends the California Transportation Commission (Commission) approve State Transportation Improvement Program (STIP) Amendment 08S-007. This item was noticed at the Commission's October 2008 meeting.

ISSUE:

The Inyo County Local Transportation Commission proposes to amend the STIP to reduce the scope of the Independence Town Rehabilitation Project (PPNO 2556) and add the Riverside Bridge Project (PPNO 2570).

BACKGROUND:

Kearsarge Street and South Clay Street received asphalt concrete overlays last year and do not require further work. It is proposed to delete Kearsarge Street and South Clay Street from the scope of the Independence Town Rehabilitation Project, and reduce the Regional Improvement Program (RIP) shares programmed for construction from \$1,250,000 to \$885,000 in Fiscal Year (FY) 2009-10.

Inyo County needs matching funds for the federal Highway Bridge Program funding for the Riverside Bridge project. It is proposed to add \$365,000 in RIP shares for construction to provide the necessary match in FY 2009-10. This is a revenue neutral programming action.

RESOLUTION:

Resolved, that the California Transportation Commission hereby revises the 2008 STIP (PPNO 2556 and PPNO 2570) in accordance with the attached project programming requests.
