## **RECOMMENDATION:**

The California Department of Transportation recommends that the California Transportation Commission (Commission), as a responsible agency, approve the attached Resolution E-10-35.

## **ISSUE:**

The attached resolution proposes to approve for future consideration of funding the following project for which a Mitigated Negative Declaration (MND) has been completed:

- Route 880 in Alameda County. Construct roadway improvements on Route 880 at the 29<sup>th</sup> Avenue and 23<sup>rd</sup> Avenue overcrossings in the city of Oakland. (PPNO 0044C)

This project in Alameda County will construct roadway and safety improvements on Route 880 at the 29<sup>th</sup> Avenue and 23<sup>rd</sup> Avenue overcrossings in the city of Oakland. The project is programmed in the Trade Corridors Improvement Fund and the 2010 State Transportation Improvement Program and includes federal demonstration and local funds. Construction is estimated to begin in Fiscal Year 2012-13. Total estimated project cost is \$96,787,000 for capital and support. The scope as described for the preferred alternative is consistent with the project scope set forth in the proposed project baseline amendment.

A copy of the MND has been provided to Commission staff. The project will involve construction activities that will result in changes to the built environment and may impact visual and aesthetic resources. As a result, an MND was completed for this project.
