The Metropolitan Transportation Commission (MTC) and Alameda County Congestion Management Agency (ACCMA) are requesting the California Transportation Commission (Commission) approve this State Transportation Improvement Program (STIP) amendment. This amendment was noticed at the May 2005 Commission meeting.

Action Update: All references to reprogramming RIP TE on the Union City Intermodal Station project (PPNO 2110) have been removed from this amendment. RIP TE activities that were thought to be ineligible have now been determined to be eligible. PPNO 0115A was changed to 0112A. Also, the non-STIP funding for PPNOs 0112A and 0096A has been revised.

ACCMA proposes to reprogram \$25,000,000 in FY 2006-07 Regional Improvement Program (RIP) Construction funds from the Route 238 Northbound Widening project (PPNO 0096A) to FY 2006-07 Construction for a new Route 580 Auxiliary Lane and High Occupancy Lane project (PPNO 0112A).

RECOMMENDATION

The Department of Transportation (Department) recommends approval.

BACKGROUND

ACCMA is proposing to replace \$25,000,000 in RIP funds on the Route 238 Northbound Widening project (PPNO 0096A) with Local and Regional Surface Transportation Program (RSTP) funds to provide sufficient funds to award the project. The \$25,000,000 in RIP funds will be reprogrammed to Construction in FY 2006-07 on a new Route 580 HOV Lane project (PPNO 0112A) to construct an HOV lane in the eastbound direction between Santa Rita/Tasajara Road and Greenville Road. This project will help relieve the heavily congested section of Route 580 by providing an HOV lane. ACCMA is contributing \$4,500,000 in local sales tax funds towards this project.

RESOLUTION

Resolved, that the California Transportation Commission revise the 2004 State Transportation Improvement Program at the end of the 30-day notice period as follows:



PPNO 0096A


Location: Near San Leandro, Route 238 from Route 580 to Route 880; Route 880 from A Street to Route 238.
