## **RECOMMENDATION:**

The Department of Transportation (Department) recommends the California Transportation Commission (Commission) approve the following resolution, allocating **\$1,750,000** for **two** locally-administered State Transportation Improvement Program (STIP) projects.

## **ISSUE:**

The attached list describes **two** locally-administered STIP Rail/Transit projects totaling **\$1,750,000**, plus **\$23,625,000** from other sources. The agencies are ready to proceed and are requesting an allocation at this time.

## **FINANCIAL RESOLUTION:**

Resolved, that **\$1,750,000** be allocated from the Budget Act of 2006, Budget Act Item 2660-101-0046, for **two** locally-administered STIP Rail/Transit projects, as described on the attached vote list.
