Subject: **FINANCIAL ALLOCATION FOR LOCALLY ADMINISTERED TRANSIT PROGRAM  
PROJECTS OFF THE STATE HIGHWAY SYSTEM  
RESOLUTION MFP-11-01**

**CTC ACTION UPDATE: The California Transportation Commission took action on as follows:  
Project 1 (PPNO 02-2449) was approved for \$327,000. Project 2 (PPNO 07-4026) will be placed  
on the “Delivered but Not Yet Allocated” list.**

## **RECOMMENDATION:**

The California Department of Transportation (Department) recommends the California Transportation Commission (Commission) approve an allocation of \$35,627,000 for two locally administered transit projects programmed in the State Transportation Improvement Program (STIP).

As reflected in the 2012 Fund Estimate presented at the June 2011 Commission meeting, the Public Transportation Account (PTA) capacity is insufficient to fund all PTA qualified STIP projects.

## **ISSUE:**

The attached vote list describes two locally administered STIP Transit projects totaling \$35,627,000. The local agencies are ready to proceed with these projects and are requesting allocations at this time.

## **FINANCIAL RESOLUTION:**

Resolved, that ~~\$35,627,000~~ **\$327,000** be allocated from the Budget Act of 2011, Budget Act Item 2660-101-0046 for ~~two~~ **one** locally administered STIP Transit ~~projects~~ **project** described on the attached vote list.
