

Subject: FINANCIAL ALLOCATION ADJUSTMENT FOR AWARD  
RESOLUTION FA-07-08, AMENDING RESOLUTION FP-06-115

## RECOMENDATION:

The Department of Transportation (Department) recommends the California Transportation Commission (Commission) approve the resolution below, adjusting the allocation amount for a Sutter/Yuba 70 corridor project near East Nicolaus (PPNO 0289P) from \$126,000,000 to \$82,360,000.

## ISSUE:

Section 188.8 of the Streets and Highways Code allows the Commission to adjust an allocation amount for a capital outlay project in the State Transportation Improvement Program (STIP) if the construction contract award amount for the project is less than 80 percent of the engineer's final estimate. The result would be an adjustment to interregional and/or county shares. The legislation is permissive and it is understood that adjustments to allocations are at the discretion of the Commission.

The Department, Sutter County, and Yuba County are requesting a downward adjustment of \$43,640,000 for the Sutter/Yuba 70 corridor project (PPNO 0289P). Savings of **\$3,762,000** for Sutter County and **\$7,934,000** for Yuba County to be returned to the respective County regional share. The Sacramento Area Council of Governments agrees to reprogram Sutter County's savings on Segment 2 of the Route 99 Widening Feather River Bridge project and Yuba County's savings on the Feather River Boulevard Interchange/70 project. Both projects are within the Route 70/99 corridor in close proximity to the project generating the savings and will have direct benefits to that project.

The remaining savings of \$31,944,000 is requested to be returned to the Interregional Improvement Program share. This savings will be used to program projects in the 2008 STIP.

**BACKGROUND:**

On June 7, 2007, the Commission approved Resolution FP-06-115 allocating \$126,000,000 for the Sutter/Yuba 70 corridor project programmed in the STIP. The project was awarded on December 6, 2007, for \$82,360,000, including supplemental work, state furnished materials, and contingencies.

**FINANCIAL RESOLUTION:**

Resolved, pursuant to Section 188.8 of the Streets and Highways Code, that the amount allocated under Resolution FP-06-115 for Sutter/Yuba 70 corridor project near East Nicolaus (PPNO 0289P) be adjusted by \$43,640,000 (\$31,944,000 to Interregional share balance; **\$3,762,000** to Sutter County share balance; **\$7,934,000** to Yuba County share balance), from \$126,000,000 to \$82,360,000 in accordance with the attached revised vote box.
