SUBJECT: SLOCOG 2008/09 TIP/FSTIP AMENDMENT NO. 3

The Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) have completed our reviews of Amendment No. 3 to the San Luis Obispo Council of Governments (SLOCOG) portion of the 2008/09 Federal Statewide Transportation Improvement Program (FSTIP) that was submitted by your letter dated March 27, 2009. The SLOCOG Board of Directors endorsed this amendment to SLOCOG's 2008/09 Transportation Improvement Program (TIP) on March 4, 2009, by approving Resolution No. 09-01. Based on our review of the information submitted with this FSTIP amendment request, Amendment No. 3 to SLOCOG's 2008/09 TIP proposes to add fourteen new individually listed projects to the 2008/09 TIP and FSTIP, modifies the funding for two grouped project listings previously approved for inclusion in the FSTIP, modifies the funding information for three projects that is outside the four-year FTIP/FSTIP programming cycle, and modifies the funding listed for one individually listed project that was previously approved for inclusion in the FTIP/FSTIP.

Based on our review, we approving the additions and modifications to the 2008/09 FSTIP proposed by this SLOCOG Amendment. However, pursuant to 23 CFR §450.216(a), since this amendment proposes modifications beyond the four year TIP/STIP cycle for the following three projects, the FHWA and the FTA consider the modifications to the FTIP/FSTIP for these projects as informational:

1. MPO ID 113-0000-0314 (E. Branch Street Streetscape)
2. MPO ID 113-0000-0284 (Morro Bay to Cayucos Connector)
3. MPO ID 213-0000-0136 (SLO City Coach Purchase (5307) – SLO UZA)



Pursuant to the July 15, 2004, *Memorandum of Understanding between the Federal Highway Administration, California Division, and the Federal Transit Administration, Region IX*, we accept these modifications to the 2008/09 FSTIP for the SLOCOG region in accordance with the Final Rule on Statewide and Metropolitan Transportation Planning that was published in the February 14, 2007 Federal Register. We find that SLOCOG's 2008/09 TIP, through Amendment No. 3, was developed through a continuing, cooperative and comprehensive transportation planning process carried out in accordance with the metropolitan planning provisions of 23 U.S.C. 134, and 49 U.S.C. Chapter 53 as amended by Section 6001 of Public Law 109-59, the *Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users* (SAFETEA-LU).

The changes proposed to the FSTIP by this amendment are associated with transportation projects proposed for implementation in an area of the State of California that is designated as attainment for Federal air quality standards and, as a consequence, this program amendment is not subject to the requirement that an air quality conformity determination be made.
