The California Department of Transportation has completed the review of the following amendments to the Sacramento Area Council of Governments' (SACOG) 20010/11 - 2013/14 Federal Transportation Improvement Program (FTIP):

31	State, Local and Transit Elements <ul style="list-style-type: none"> This amendment modifies one project in Sacramento County with funding from State Bonds, the State Transportation Improvement Program, Federal Transit Administration (FTA) Section 5309, and local funds.

The SACOG board resolution adopting this FTIP amendment certifies that the project included meets all applicable transportation planning requirements per Title 23 Code of Federal Regulation (CFR) Part 450 and satisfies the applicable air quality conformity requirements.

Pursuant to the authority delegated to me by the Director of Caltrans, I approve SACOG's Amendment Number 31. I also recommend that the Federal Highway Administration and FTA approve this FTIP amendment for inclusion into California's 2011 Federal Statewide Transportation Improvement Program (FSTIP). Projects included in this FTIP amendment, in fiscal years not within the four-year cycle of the current FSTIP, are not approved as part of this FTIP amendment and are shown for information only. Approval of this amendment does not constitute an eligibility determination of project for federal funding.
