The California Department of Transportation (Caltrans) has completed the review of the following amendment to the Fresno Council of Governments' (FCOG) 2012/13 – 2015/16 Federal Transportation Improvement Program (FTIP).

This amendment adds and modifies projects in the FCOG region with funding from the Congestion Mitigation and Air Quality Improvement Program, Regional Surface Transportation Program, Recreational Trails Program, Federal Transit Administration (FTA) 5310 and 5316 Programs.

FCOG has certified that this amendment is financially constrained, does not change air quality conformity, and meets the requirements of public involvement procedures adopted by FCOG.

Pursuant to the authority delegated to me by the Director of Caltrans, I approve FCOG's Amendment Number 10. I also recommend that the Federal Highway Administration (FHWA) and the FTA approved this FTIP amendment for inclusion into California's 2013 Federal Statewide Transportation Improvement Program (FSTIP). Approval of this amendment does not constitute an eligibility determination of projects for federal funding.
