The California Department of Transportation (Caltrans) has completed the review of the following amendment to the Kings County Association of Governments (KCAG) 2012/13-2015/16 Federal Transportation Improvement Program (FTIP):

- This amendment adds, removes, and modifies projects from the KCAG region funded from the Congestion Mitigation and Air Quality Improvement Program, Highway Bridge Program, State Highway Operation and Protection Program, and State Transportation Improvement Program.

The KCAG Board Resolution adopting this FTIP amendment certifies that the amendment is financially constrained, consistent with the adopted conformity analysis, and meets the requirements of public involvement procedures adopted by KCAG.

Pursuant to the authority delegated to me by the Director of Caltrans, I approve KCAG Amendment Number 2. I also recommend that the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) approve this FTIP amendment for inclusion into California's 2013 Federal Statewide Transportation Improvement Program (FSTIP). Projects included in this FTIP amendment in fiscal years not within the four-year cycle of the current FSTIP are not approved as part of this FTIP amendment and are shown for information only. Approval of this amendment does not constitute eligibility determination of projects for federal funding.
