The California Department of Transportation (Caltrans) has completed the review of the following amendment to the Sacramento Area Council of Governments (SACOG) 2012/13 - 2015/16 Federal Transportation Improvement Program (FTIP):

8	State and Local Elements Amendment adds, modifies and deletes projects from SACOG region. The amendment includes projects funded from various programs including the Surface Transportation Program, Congestion Mitigation and Air Quality Improvement Program, Highway Safety Improvement Program, High Priority Projects Program, and the Proposition 1B – Transportation Bond Program. SACOG has certified that the amendment does not affect air quality conformity, and meets the requirements of public involvement procedures adopted by SACOG.

Pursuant to the authority delegated to me by the Director of Caltrans, I approve SACOG's Amendment No. 8. I also recommend that the Federal Highway Administration and the Federal Transit Administration approve this FTIP amendment for inclusion into California's 2013 Federal Statewide Transportation Improvement Program (FSTIP). Projects included in this FTIP amendment, in fiscal years not within the four-year cycle of the current FSTIP, are not approved as part of this FTIP amendment and are shown for information only. Approval of this amendment does not constitute an eligibility determination of project for federal funding.
