The California Department of Transportation (Caltrans) proposes to install transportation management system elements and roadside safety improvements at six locations in Amador, El Dorado, and Alpine counties along State Routes 88 and 89.

WHAT IS BEING PLANNED? Caltrans has studied the effects this project may have on the environment. The studies show the project would not significantly affect the quality of the environment, as documented in our report called an Initial Study with Proposed Mitigated Negative Declaration, which is now
