EXTENSION OF PUBLIC COMMENT PERIOD FOR THE STATE ROUTE 70 BINNEY JUNCTION ROADWAY REHABILITATION AND COMPLETE STREETS PROJECT DRAFT ENVIRONMENTAL IMPACT REPORT OCTOBER 23, 2024 TO DECEMBER 20, 2024

WHAT IS PLANNED:

In coordination with Yuba County, the City of Marysville, and Union Pacific Railroad, Caltrans proposes to rehabilitate State Route 70 0.1 mile south of 14 Street in Marysville to the north of Cemetery Road. This project will provide complete street features, rehabilitate the existing pavement, reduce traffic congestion and improve traffic operations and safety.

WHAT IS AVAILABLE:

The environmental document referred to as a Draft Environmental Impact Report is available for review from October 23, 2024 and the review period has been extended to end on December 20, 2024. The document is available to review, at the Sutter County Library, 750 Forbes Avenue, Yuba City, CA 95991.
