### SAN MATEO 101 EXPRESS LANES PROJECT

FACTSHEET



## PROJECT OVERVIEW:

The California Department of Transportation (Caltrans), in partnership with the San Mateo County Transportation Authority (SMCTA) and City/County Association of Governments of San Mateo County (C/CAG), is constructing express lanes on U.S. 101.

This project is being completed in two phases. During Phase One, Caltrans converted the existing carpool lanes from the San Mateo County/Santa Clara County Line to Whipple Avenue in Redwood City into Express Lanes. These Express Lanes are expected to open soon.

During Phase Two, Caltrans is adding a lane to northbound and southbound U.S. 101 from Whipple Avenue to just north of I-380 in South San Francisco. The project will ultimately create 22 miles of express lanes in both directions of U.S. 101 within San Mateo County and provide a seamless transition to the express lanes being constructed in Santa Clara County. The Express Lanes in this phase are expected to open in late-2022.

# Construction Progress and Recent Work:



Construction crews repaying the freeway lanes north of Broadway.

Crews rehabilitated both sides of U.S.101 from Burlingame to South San Francisco and will add a final layer of asphalt/new paint by mid-2022.



Construction crews removing an existing overhead sign structure on U.S. 101.

Caltrans removed six overhead sign structures and installed temporary orange roadside signs along the freeway shoulder on U.S. 101. Additional overnight freeway closures will be required to install new overhead sign structures in late 2021/early 2022.



- Reduce congestion in the corridor
- Increase person throughput (the number of people moved)
- Encourage carpooling and transit use
- Improve travel time and reliability for express lane users
- Use modern technology to manage traffic
- Make upgrades to pavement and lane striping
