The California Department of Transportation (Caltrans) proposes to preserve 22.2 Lane Miles of Class 2 pavement, beyond gore area paving, rehabilitate one drainage system, replace traffic Management Systems elements, lighting rehabilitation, bicycle and pedestrian infrastructure, and upgrade guardrail to the Manual for Assessing Safety Hardware (MASH) standards. The proposed project is located on State Route 1 in Monterey County, from 0.28 miles south of the South Marina
