






#### FY 2022 & 2023 Federal Wildlife Crossings Pilot Program California Department of Transportation Project Name: Gaviota Pass Wildlife Connectivity and Vehicle Collision Reduction

The Gaviota Pass Wildlife Connectivity and Vehicle Collision Reduction Project proposes to replace an existing culvert on US-101 at postmile 46.37 with a wildlife crossing and install 2.5 miles of wildlife fencing to prevent atgrade road crossings. The culvert is currently undersized for large animals however, it is in an excellent location to promote habitat connectivity between high-quality protected habitat on either side. Replacing it with a larger pre-cast structure will improve wildlife-movement function for large animals, reduce wildlife vehicle collisions (WVC), enhance safety for the traveling public, and will allow a full suite of species to access habitat on either side of the highway and beyond. Additionally, wildlife fencing will prevent at-grade road crossings and funnel animals to existing structures suitable for wildlife crossing. Informational signage will be installed at nearby trailheads and rest areas to educate the public about WVCs and the project's wildlife connectivity improvements.


#### Where do we go from here?
