## Notice of Public Hearing and Notice of Availability of a Draft Environmental Impact Report/Environmental Assessment

The California Department of Transportation (Caltrans) has completed the Draft Environmental Impact Report/Environmental Assessment (EIR/EA) for the State Route 39 (San Gabriel Canyon Road) Reopening Project. The proposed project would restore and reopen a section of State Route 39 (SR-39) in the Angeles National Forest that has been closed to public traffic since 1978 due to recurring rockslides and concerns over public safety; the project would address those safety concerns. The project location is shown on the map on page three.


