# **OVERVIEW AND OBJECTIVES**

The I-110 corridor stretches from the South Bay, near the Port of Los Angeles, to Downtown Los Angeles, near the I-110/I-5 Interchange. It also encompasses the transit and active transportation options that run along the corridor, most notably the Metro J (formerly Silver) Line Express Busway.

# **OBJECTIVES OF THE PLAN INCLUDE THE FOLLOWING:**

- Encourage effective communication and transparent planning processes with allstakeholders.
- Preserve the character of local communities, create opportunities for neighborhoodenhancement, and improve multimodal accessibility including complete streets
- Task a multi-disciplinary, multi-organizational corridor project development team tolook at community, State, and local transportation systems.
- Support Federal / State air standards and greenhouse gas (GHG) emissions reduction.
- Identify and prioritize projects, strategies, and opportunities to provide a balancedfuture corridor.

# **PLAN STUDY AREA**

The plan encompasses a key north-south corridor in the coastal Los Angeles County and Ventura County, from Ocean Ave in Santa Monica to Pleasant Valley Road in Oxnard. **See map below.**

# **CORRIDOR PLAN APPROACH**

# **MANAGED LANES/OTHER PROJECTS**

- SI-110 was identified in the Caltrans District 7 Integrated Corridor Management (ICM) Master Plan as a potential
  candidate corridor for ICM implementation in District 7, between I-105 and I-10. Planned ICM improvements and
  integrations include traffic signals, Transportation Management Systems (TMSs), and other improvements
  including Bluetooth devices that transmit speed and travel times along arterial routes, Closed-Circuit Television
  (CCTV), and Dynamic Message Signs (DMSs)
- Metro Traffic Reduction Study (Congestion pricing) study in Downtown Los Angeles
- 110 Adams Terminus Improvement Project
