

PUBLIC NOTICE Draft Environmental Impact Report (EIR)/Environmental Assessment (EA) Available for the I-40 Colorado River Bridge Replacement Project Announcement of Virtual Public Hearing ARIZONA MOHAVE COUNTY CALIFORNIA 40 Colorado River SAN BERNARDINO **Project Location** COUNTY WHAT'S The California Department of Transportation (Caltrans) in cooperation with the Arizona Department of Transportation (ADOT) BEING proposes to replace the Colorado River Bridge (California Bridge No. 54-0415, Arizona Bridge No. 957) spanning the California/Arizona state line on I-40 near Topock, Arizona. The purpose of the project is to improve the safety and integrity of the **PLANNED?** structure by addressing deck deterioration and strengthening the girders to increase the load rating. The safety of the traveling public will also be enhanced because standard lane and shoulder widths are proposed as well as an upgrade to the bridge rail system. There are three build alternatives in addition to the No-Build Alternative being evaluated. Alternative 1 (Existing Alignment) would construct a new bridge on the existing alignment, Alternative 2 (Northern Alignment) proposes to replace the bridge with an alignment to the north of the existing bridge, Alternative 3 (Southern Alignment) proposes to replace the bridge with an alignment to the south of the existing bridge, and Alternative 4 (No-Build Alternative). The proposed work will encroach upon wetlands. The project is being evaluated to determine if there are any practical alternatives to avoid this encroachment or, if not, to ensure that all practical measures are taken to minimize harm to the wetlands. WHY THIS Caltrans has studied the effects this project may have on the environment. Our studies show it would significantly affect the quality **NOTICE?** of the environment. The report that explains why is called an EIR/EA. This notice is to inform you of the preparation of the Draft EIR/EA and of its availability for you to read. A virtual public hearing will be held to give you an opportunity to comment and provide relevant input before an alternative is selected.
