****Service Payables Alpha Determination:**

- For invoices beginning with **State, California State** or other references to State use the Department's name
 - Example: State of California, Department of Insurance. This is an "I"
- For invoices beginning with **City, County** or other reference to City or County, use the City or County's name
 - Example: City of Sacramento, Sacramento City. These are "S"
 - Example: County of Los Angeles, Los Angeles County. These are "L"
- For invoices which contain a **last name** in the title, the last name will be used
 - Example: Robert James, Company. This is "J"
 - Example: William Smith. This is "S"
- For invoices with no last name in the **company title**, the first name or reference will be used
 - Example: Ace Hardware. This is an "A"
- For invoices with all **last name** or multiple last names, use first last name
 - Example: Brown & Caldwell. This is a "Br"
 - Example: Boster, Kobayashi & Associates. This is a "Bo"
- For invoices with **University and U.C. Regents**, use the City for alpha determination
 - Example: University of California, Berkley. This is "Be"
 - Example: U.C. Regent, Irvine. This is "I"

- For invoices with **The**, use the word that come after The for the alpha determination
 - Example: The Support Group Inc. This is “Su”
 - Example: The Diesel Doctor, Inc. This is “D”
