WHAT IS SENATE BILL 1 & HOW DOES IT IMPACT YOU?



Senate Bill 1

- Also known as the California Road Repair & Accountability Act of 2017, with a goal of rehabilitating California's aging transportation infrastructure to improve transit system efficiency & safety
- Invests \$54 billion over a 10 year period
 - Funds split evenly between state and local public works
- Four major focuses
 - Road repaving
 - Bridges
 - Culverts
 - Traffic corridor decongestion



Senate Bill 1 Impact for your firm

- White House Council of Economic Advisors found that every \$1 billion invested in transportation infrastructure supports 13,000 jobs per year
- Caltrans in partnership with our Prime contractors and their sub-contractors are putting people to work rebuilding California.
- Caltrans is committed to increasing participation of Small Businesses on state-funded projects by 100%

Contracts and Purchases

Public Works

- Major/Minor Highway Construction and Maintenance
- Architectural & Engineering (A&E) Consulting Services
- Emergency Maintenance

Goods and Services

- Supplies and Equipment
- Operations and Safety
- Office and IT equipment
- Supplies for Facility Maintenance



State and Federal Funds

- Caltrans receives both California state funds and Federal funds via the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA)
- These funds come with requirements and expectations from each level of government detailing how they will be spent & requirements for disadvantaged groups' participation
- Integrity of disadvantaged groups' participation is tracked via the use of various certification programs, which are overseen or administered by the Caltrans Office of Civil Rights





CERTIFICATIONS RECOGNIZED BY CALTRANS





Certifications Recognized by Caltrans

State Funded Projects

(When project funding is <u>ONLY</u> state dollars)

Small Business (SB)/Small Business - Public Works (SBPW)

25% Goal

Disabled Veteran Business Enterprise (DVBE)

5% Goal

Federally Funded Projects

(When projects have <u>ANY AMOUNT</u> of federal dollars)

Disadvantaged Business Enterprise (DBE) 22.2% Goal



Benefits of Certifications

SB/SB-PW and DVBE Benefits

- 5% Bid Preference (SB only)
- SB/DVBE Option
- DVBE Incentive (DVBE only)
- Listing in Statewide SB/DVBE Database on Cal eProcure
- Durable for all State departments
- Invitation to procurement fairs and pre-bid meetings

DBE Benefits

- Desired by Primes to fulfill their
 DBE goal requirements
- Listed in California Unified Cert.
 Program (CUCP) data
- Recognized by Local agencies
- Invitation to procurement fairs and pre-bids



SB/SB-PW Eligibility

Small Business (SB)

- Principal office and owner(s) home located in California
- 100 or fewer employees
- Average annual gross receipts of \$15,000,000 or less for last three tax years

Small Business for Public Works

<u>(SB-PW)</u>

- Principal office and owner(s) home located in California
- 200 or fewer employees
- Average annual gross receipts of \$36,000,000 or less for last three tax years



DVBE Eligibility

- Must be At least 51% owned by one or more service disabled veterans
 - Veteran of U.S. military, naval, or air service with service-connected disability of 10% or more
- Veteran(s) must reside in California
- Daily operations managed and controlled by disabled veteran(s)
- Home office located in U.S.





DBE Eligibility

- For-profit small business
- Must be At least 51% owned by one or more socially and economically disadvantaged individual(s)
 - Presumptive groups include African Americans, Hispanic Americans, Native Americans, Asian-Pacific Americans, Subcontinent Asian-Americans, Women, and others
- Personal net worth not exceeding \$1.32 million
- Average gross annual receipts for last three fiscal years must not exceed \$26.29 million
- U.S. Citizen or permanent residence
- Managerial and operational control of business





How To Get Certified

SB/SB-PW, DVBE Process

- Completed via Department of General Services' (DGS) CaleProcure system
- Apply online and submit supporting documents electronically
- SB renews every two years,
 DVBE annually unless also SB

DBE Process

- Completed via Caltrans or other certifying transportation agency
- Submitted after signing and notarizing
- Certification doesn't expire, but requires annual documentation verifying DBE meets requirements

FREQUENTLY ASKED QUESTIONS (FAQ)









How do I find out if Caltrans needs the goods or services that my company offers?

Search current bid opportunities on Cal-eProcure, past purchasing records on Fi\$Cal's State Contract & Procurement Registration System (SCPRS) or contact your nearest Caltrans District Small Business Liaison (DSBL)

My business is HUBZone/8(a)/SDVOSB certified, will Caltrans accept my certification? No, only the SB/SB-PW, DVBE, and DBE certification are recognized by Caltrans.

Can you give me a contact list of Caltrans purchasers?

We have many purchasing staff in various departments across the state, please contact your local DSBL for more information about how to sell your product or service to Caltrans.





Do I need my last three years of tax information for DBE Certification? What if I haven't been in business for three years? Please contact Caltrans Certification branch at dbe.certification@dot.ca.gov to discuss your specific tax situation.

What is the cost to get certified and is there a cost to get help from a DSBL?

Certifications are no costs, however, the DBE certification does require your application and personal net worth statement to be notarized, this cost will vary depending on the notary service you choose. There are no costs associated with receiving assistance from DSBLs.
