What is a Commitment At Award (CAA) Report?

The CAA is a monthly report that identifies contracts awarded to prime contractors/consultants and Disadvantaged Business Enterprise (DBE) subcontractors/sub-consultants, as shown on commitment forms, for each federal-aid contract awarded in the current federal fiscal year. The CAA breaks down DBE subcontractors/sub-consultants by ethnicity/gender and the dollar amount for each group.

There are five division-specific CAA reports: the Office of Engineers (OE), Division of Local Assistance (DLA), Division of Procurement and Contracts (DPAC), Design-Build (DB), and Construction Management General Contracts (CMGC), and Division of Transportation Planning (DOTP).

- Caltrans has awarded 100 Federal Highway Administration (FHWA)-assisted contracts (OE, DPAC, DLA, DOTP, DB, and CMGC contracts) in FFY 2024-25, valued at \$1,426,507,486.68.
 - Total DBE commitment at award is \$332,069,856.44 or 22.58 percent.
- Caltrans has awarded 1 FHWA-assisted CMGC contract in FFY 2024-25, valued at \$79,019,296.00.
 - Total DBE commitment at award is \$14,606,899.13 or 18.49 percent.
- There were no Design Build contracts were awarded this month.

- Caltrans has awarded 13 FHWA-assisted A&E contracts in FFY 2024-25, valued at \$188,617,359.00.

Year-Over-Year Socially & Economically Disadvantaged Group from FFY 2022-23 through FFY 2024-25

The table below represents a three-year comparison of the reported month's total DBE Commitment at Award for each Socially & Economically Disadvantaged (SED) Group. Over the past three years, Caltrans overall DBE participation has increased. For January 2025, Caltrans committed over \$322 million to DBE firms. This is a 14.03 percent increase above the January 2024 commitment dollars of over \$282 million.
