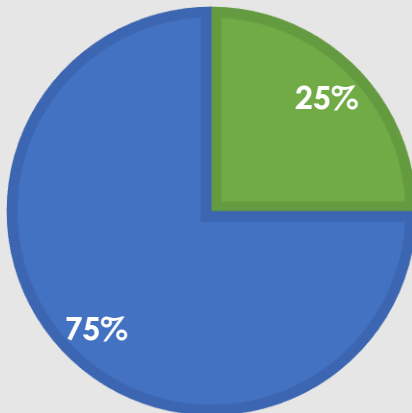

Participation at a glance:

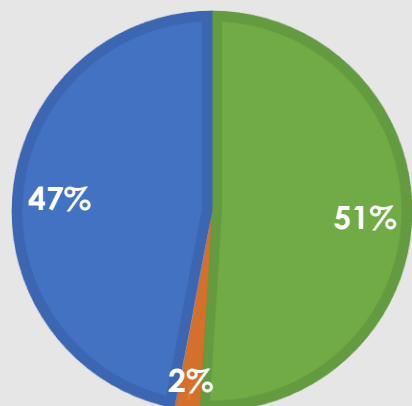
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$71,316,936

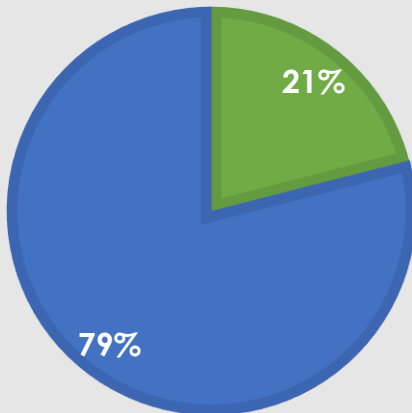

Participation at a glance:

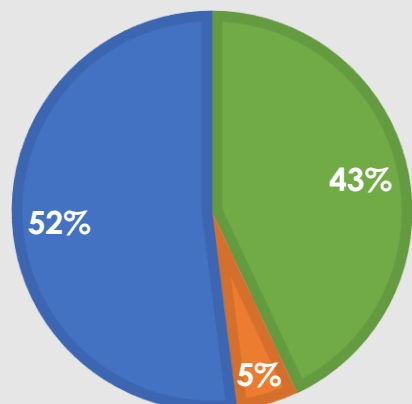
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$142,764,815

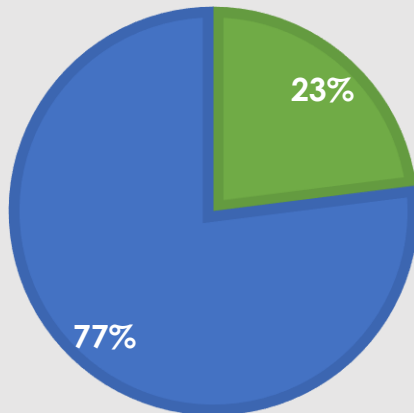

Participation at a glance:

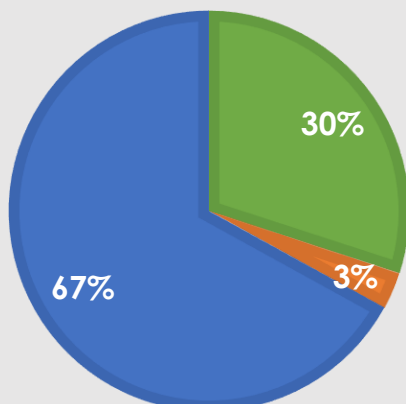
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$59,119,927

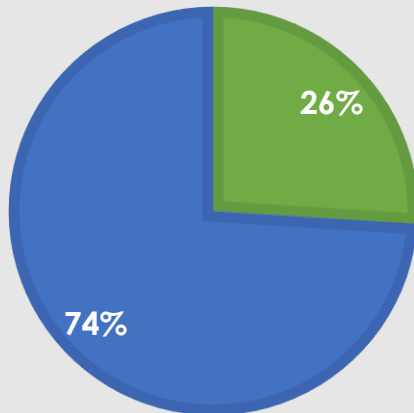

Participation at a glance:

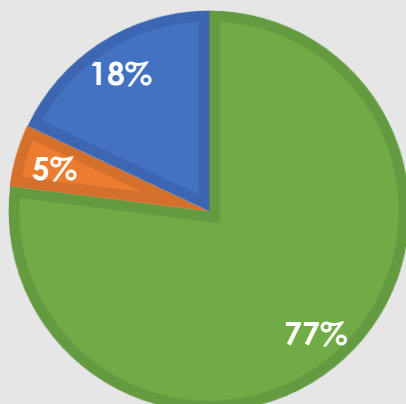
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$102,243,102
