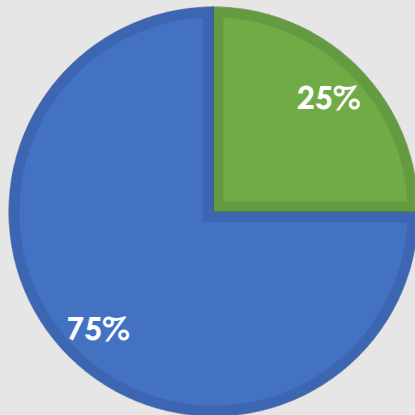

Participation at a glance:

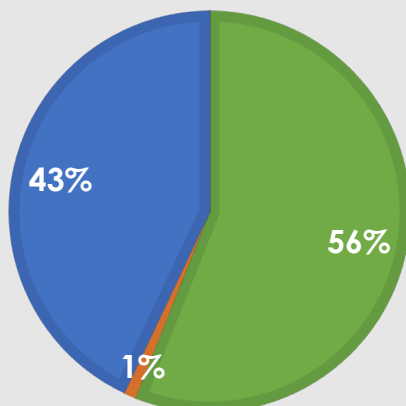

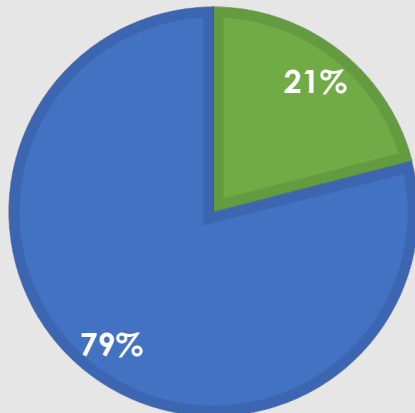

Participation at a glance:

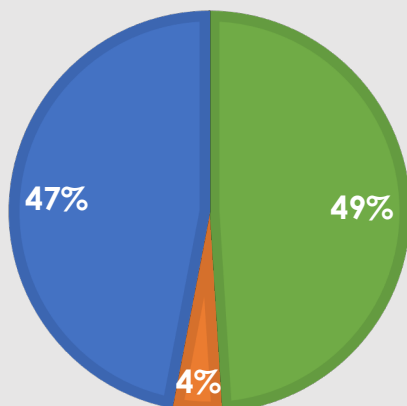

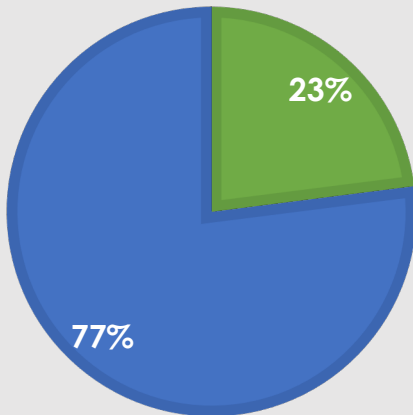

Participation at a glance:

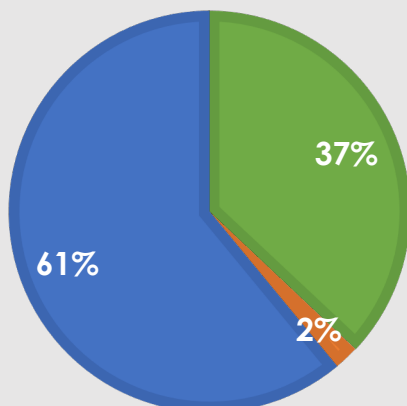

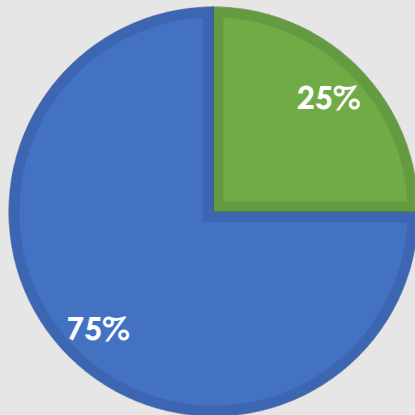

Participation at a glance:

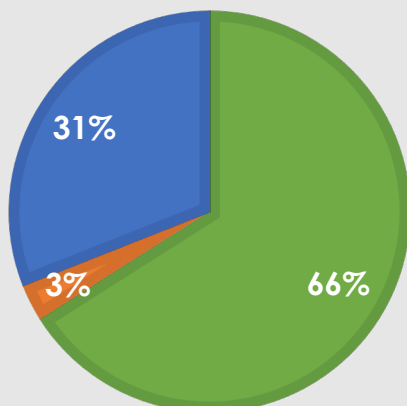
## FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$147,573,116
