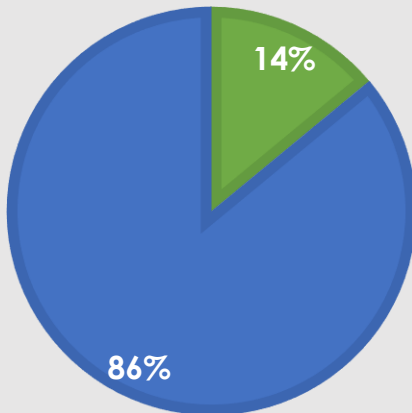

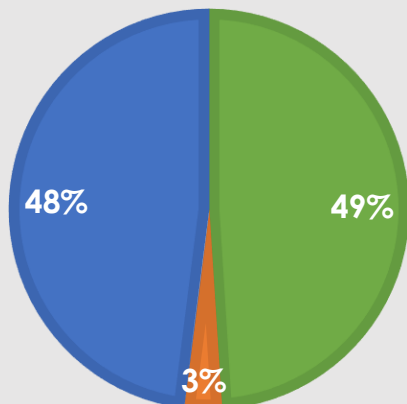

**DISTRICT DIRECTOR'S REPORT**

District 5 continues to promote Small Business participation in contracts and procurement. A recent success story is that we awarded two contracts to Whitaker Construction, a certified Small Business out of Paso Robles, CA. Both contracts addressed deficient culverts in San Luis Obispo County on Highway 1 near the elephant seal viewing area. The first contract is to line a 48" CSP culvert and is valued at \$195,000. The second contract is to line an 84" CSP culvert, valued at \$550,000.

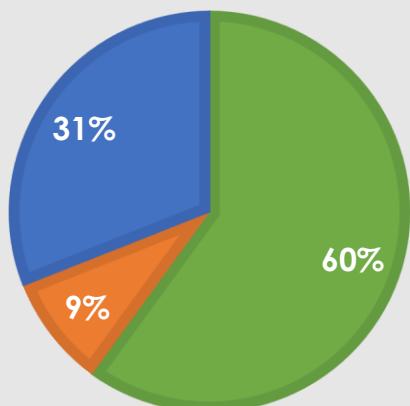

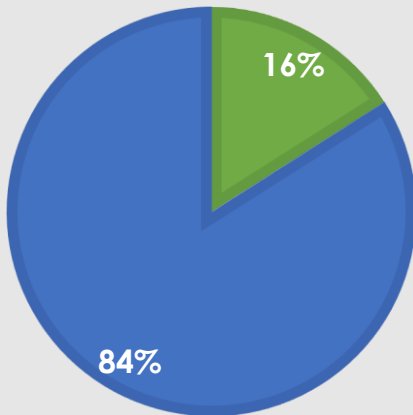

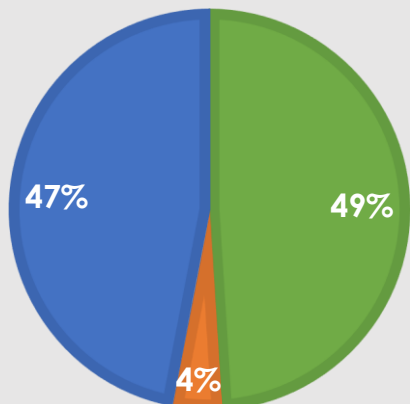

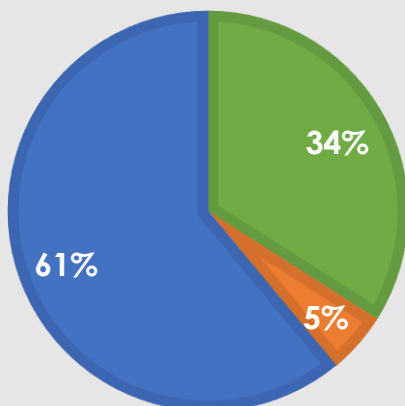
