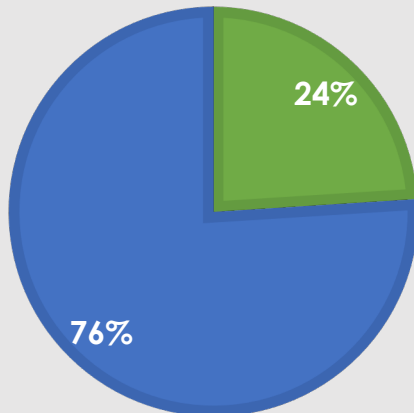

Participation at a glance:

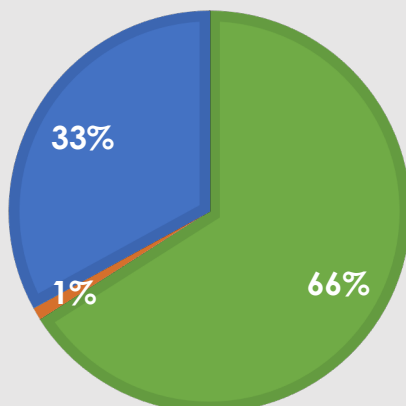

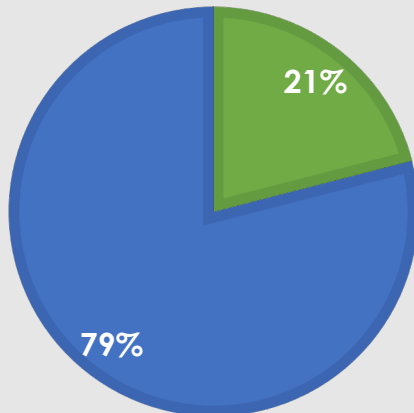

Participation at a glance:

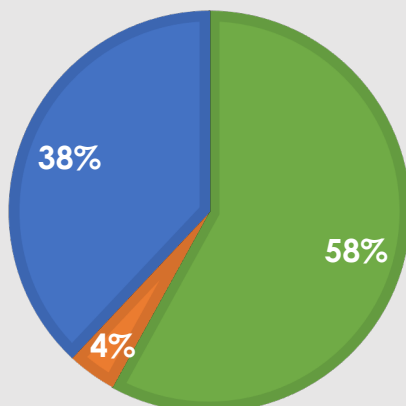
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$144,253,367

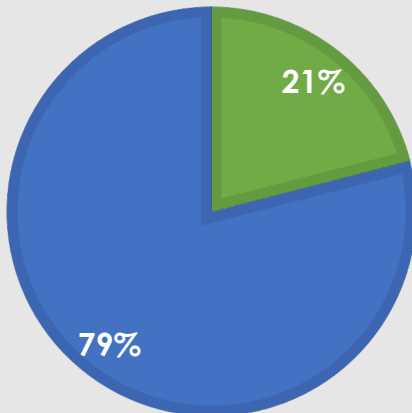

Participation at a glance:

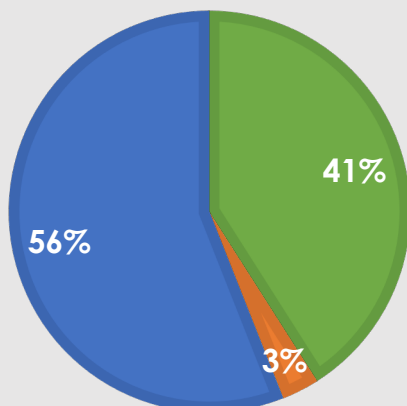
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$74,774,167

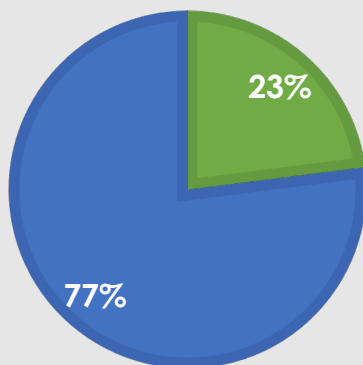

Participation at a glance:

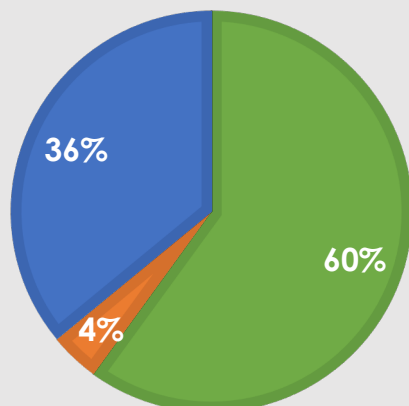
FEDERAL MAJOR CONSTRUCTION CONTRACTS TOTAL \$223,233,526
