**Subject:** CADD Users Manual Update

The CADD Users Manual is being updated to document changes to the CADD standards. These changes, which are already being practiced by the districts, reflect the current Caltrans development/delivery process for projects developed in metric and delivered in the MicroStation file format (version 5 through 7). This update incorporates previous changes addressed in the CADD Standards Update Memorandum (dated September 24, 2003), with the exception of item 4 in Attachment 1. Item 4 will be included in the ongoing update of the Plans Preparation Manual.

This Manual update is being completed incrementally, and will be updated on the Caltrans Internet Web pages only. As sections are completed, they will be posted to the web. Each section within a Chapter will have the date it was revised. The first part of the update will be posted on September 1, 2004, and includes:

- Complete revisions of Chapters 1 & 2 and the Appendix.
- A new chapter, (Chapter 5) that discusses Caltrans plotting standards.

The second part of the update, scheduled for completion by spring 2005, will include:

- Complete revision of Chapter 3. Portions of Chapter 3 will be moved to other chapters and new topics will be included.
- Deletion of Chapter 4 to be replaced by sections discussing PS&E and As-builts (currently located in Chapter 3).
- The addition of several new sections to Chapter 2 covering new topics.

Future updates to the CADD Users Manual will be required when Caltrans implements MicroStation version 8 and when the conversion back to English measurements is made.
