

# Caltrans CalNAGPRA and NAGPRA Compliance

#### **Background**

This informational sheet is being provided as an acknowledgement of the California Department of Transportation's (Caltrans) responsibilities under, and implementation of, the California Native American Graves Protection and Repatriation Act (CalNAGPRA), as revised by Assembly Bill 275 (AB 275; codified as Health and Safety Code §§ 8010-8030), and the federal Native American Graves Protection and Repatriation Act (NAGPRA; 43 CFR Part 10).

### Caltrans Commitments

- Committed to working in earnest to comply with CalNAGPRA and NAGPRA so that human remains and identified objects can be returned home respectfully and efficiently
- Recognition that AB 275 amended the operative language of CalNAGPRA, adding concepts which were not previously included in CalNAGPRA or NAGPRA
- Addressing each collection on a case-by-case basis in consultation with individual tribes to ensure tribal identification of human remains and objects meeting the definitions of items subject to repatriation under CalNAGPRA and NAGPRA
- Ensuring that the consultation and repatriation processes are transparent and documented, the constituents of the repatriated collections are identified, and the subsequent agreements, notices, and transfers are clear and complete
- Identifying opportunities to support tribes in the repatriation process
- Continue to adapt as the AB 275 regulations and dispute resolution process are developed

## **Caltrans Actions**

- Established District Points of Contact (AB 275 POCs) in each of the 12 Caltrans Districts
- Actively consulting in good faith and transparency with all California Indian tribes
- Uploaded all inventories/summaries to the NAHC portal for posting
- Continuing tribal consultation and documenting data from multiple lines of evidence to:
  - Establish State Cultural Affiliation (CalNAGPRA) and cultural affiliation (NAGPRA)
  - Finalize inventories/summaries with the NAHC (CalNAGPRA) and file notices with National NAGPRA (NAGPRA)
  - Process claims and engage in the NAHC's dispute resolution process if needed
- Move repatriation forward, returning home human remains and identified objects
